# **QATAR ANNOUNCES \$3BN**

 QATARI FM SAYS ECONOMIC PARTNERSHIP BETWEEN QATAR AND PAKISTAN WILL REACH \$9BN PAKISTAN AND QATAR SIGN THREE MOUS ON TRADE AND INVESTMENT. COOPERATION ON FINANCIAL INTELLIGENCE, AND TOURISM

ISLAMABAD

ATAR is making \$3 billion worth of new investments in Pakistan, in the form of deposits and direct investments, said Special Assistant to Prime Minister on Information and Broad-casting Dr Firdous Ashiq Awan on Monday.

The economic partnership between Qatar and Pakistan will reach \$9bn, Qatar News Agency quoted Foreign Minister Sheikh Mo-hammed bin Abdulrahman Al Thani as saying.

"The Qatari-Pakistani economic partnership will amount to \$9bn. Qatar affirms its aspiration for further development in the relations between the two countries at all political, economic, sports and cultural levels," said the foreign minister.

The announcement comes a day after Qatar Emir Sheikh Tamim bin Hamad Al Thani wrapped up his visit to Pakistan during which he held a one-on-one meeting with Prime Minister Imran Khan. Delegation-level talks were also held between the two sides. Prime Minister's Adviser on Finance Dr

Abdul Hafeez Shaikh thanked the Emir for "announcing \$3bn in deposits and direct investments for Pakistan and for Qatar's affirmation to further

develop relations between the two countries."

Dr Awan, while talking to the media, thanked the Qatar Emir and his cabinet for the announcement. She said that this amount will help Pakistan overcome its economic challenges, adding that Prime Minister Imran's announcement to grant visa on arrival for Qatari citizens will develop tourism sector in Pakistan. She also hailed Qatar lifting the ban on Pak-

istani rice, saying it was good news for rice exporters and the economy of the country.

AGREEMENTS SIGNED: On Saturday, fol-



lowing the Emir's arrival, Pakistan and Qatar signed three memoranda of understanding (MoUs) on trade and investment and cooperation on financial intelligence and tourism.

The signing of the MoUs was witnessed by Prime Minister Imran and Qatari Emir Sheikh Tamim.

The MoUs related to the establishment of the Pakistan and Qatar Joint Working Group on Trade and Investment, cooperation in the field of tourism and business events and cooperation in the exchange of financial intelligence related to money laundering — associated offences and terrorism financing. The last MoU was signed between Qatar's Financial Information Unit and Pakistan's Financial Monitoring Unit.

On Sunday, President Dr Arif Alvi and Emir

Sheikh Tamim held wide-ranging talks, particu-

larly the Afghan issue.

Alvi lauded Qatar's role in promoting efforts for peace and reconciliation in Afghanistan, which

was a notable contribution to regional peace.

While thanking the government and leadership of Pakistan for the gracious invitation and hospitality extended to him and his entourage during his two-day visit, the Qatari emir ac-knowledged the sacrifices made by Pakistan in the fight against terrorism.

Taking note of the progress achieved in Afghan ace talks, the two leaders agreed to continue

working closely for regional peace and stability.

## PPP CHALLENGES LEGALITY OF BAN ON USING WORD 'SELECTED' FOR PI

HE Pakistan People's Party (PPP) on Monday vowed to oppose the ban imposed by the National Assembly deputy speaker on the use of the word selected' for Prime Minister Imran

Khan.
PPP Co-Chairman Asif Ali Zardari questioned the legitimacy of the move and said the PPP would hold consulta-tions with lawyers to ascertain all possible legal options.

In an informal talk with reporters on Monday, the former president said all parliamentarians should deliberate on the government even has the authority

to impose such a ban," said Zardari. Similarly, PPP Vice President Senator Sherry Rehman said the ban on the word 'selected' was a manifestation of the prime minister's insecurities. "PPP Chairman Bilawal Bhutto-Zardari was the first person to use the word 'se-lected' for PM Imran. It is quite telling to see that this word has now become a part of Imran Khan's identity; this single word sums up his political journey," she said. She said imposing such a ban only serves to validate the assertion that PM Imran was handpicked for Pak-istan's highest office. "If the premier has not been selected, then why is the

The senator also called out what she termed the premier's hypocrisy on the matter. "A little while back, Imran Khan was clapping when the word was used [in NA] but now he is endorsing this ban. It is amusing to see a person [PM Imran] who used words such as dacoits and thieves for political opponents be this afraid of a word as inane as se-lected." She also took a swipe at the Pakistan Tehreek-e-Insaf's performance in government. "If Imran's selectors had first helped him become a councillor in Mianwali in the past, maybe Pak-istan would not be in the condition it is today. This is what happens when a person who cannot even win a councillor's

said Rehman. The senator concluded her remarks with a vow to oppose the PTI-led government's at-tempts to stifle criticism. "They [the government] can impose as many re-strictions as they want, but the public will always know that their prime min-

ister has been selected for the post."
The PPP's reaction came after NA
Deputy Speaker Qasim Suri directed MNAs to refrain from using the word 'selected' for Prime Minister Imrar Khan. "The members of the assembly have been elected through votes and the house will not tolerate any insult to them," he said during Sunday's NA

## Faryal Talpur's physical remand extended till July 8

An accountability court on Monday granted the National Accountability Bureau (NAB) 14-day physical remand of Pakistan People's Party physical remand of Pakistan People's Party (PPP) leader Faryal Talpur to investigate a cor-ruption case. Talpur, sister of PPP Co-Chairper-son Astf Ali Zardari, was nominated in a fake accounts case that is being probed by NAB. She was arrested by NAB on June 14 for alleged money laundering through fake accounts.

During the hearing, a NAB prosecutor told the court that Talpur had admitted that she transferred money to one Owais Muzaffar through the accounts, which are allegedly fake. The PPP leader had told the interrogators that she "did not know"

that the accounts were fake, he said.

The NAB prosecutor said that Talpur had told them that the Zardari Group supplied sugarcane. The anti-corruption watchdog said it had to ques-tion Talpur regarding the statements of owners of land where the sugarcane was being grown. nents of owners of

The NAB prosecutor said that it was earlier claimed that the Omni Group had transferred payments after Zardari Group supplied them with sugarcane, but in recent interrogations, Talpur had said that she did not know which sugar mill sent her the money. According to her, she was aware that sugarcane had been sold but did not know which sugar mill had bought it.
Talpur told NAB that she had received pay-

ments from those who bought sugarcane, the accounsel said. The bureau's countability

anti-accountability watchdog needs to ascertain the validity of her statement by examining the records, he added.

Latif Khosa, who is part of Talpur's legal team, said that her share in the Zardari Group was merely one per cent. Her lawyer, Farooq H. Naek, said that she had no role in the Park Lane corrup-tion case either and that NAB was "mixing every-thing up". Khosa also asked why NAB was not taking action against Aleema Khan, who was nominated in a case pertaining to assets beyond

## **QATAR MAY SECURE NAWAZ'S** RELEASE: ARIF NIZAI

## Govt to crackdown on sugar mafia, says Azhar

State Minister for Revenue Hammad Azhar on Mon day said the government has imposed a tax of only Rs3.30 per kg of sugar but it is being sold at excessive rates in the market. "The price on which the sugar is being sold in the market is high," he said while talking to media. He said the government has presented a balanced budget in difficult economic conditions, the

ntry passing through right now.

After the passage of the budget, we will conduct a survey of sugar mills with the provincial govern-ments, Azhar said and added the crackdown will be launched against those, who will be found involved in hoarding the sugar. State Minister for Revenue Hammad Azhar while presenting the budget in the National Assembly, on July 11 maintained that presently sugar was subject to sales tax at 8 percent. He stressed that



from this sector was Rs18 billion which was much lower than actual potential. "To maximize this tax gap and to harmonize its rate with other items, it is proposed that the sales tax rate on sugar may be increased to 17 percent," the state minister continued. As a result of this measure, the price of sugar was expected to in-crease by Rs3.60 per kilogram.

### **IHC DECLARES** ARBITRATION **COUNCIL'S** PERMISSION NECESSARY FOR SECOND MARRIAGE

The Islamabad High Court (IHC) on

Monday made the consent of the Arbitration Council mandatory for second marriage, IHC Justice Athar Minallah issued the detailed verdict which stated that the approval from the Arbitrary Council is obligatory for the husband despite getting a go-ahead from the first wife. According to the 1961 Muslim Family Laws Ordinance, "the person who performs a marriage without permission will be punished and fined". Furthermore, the individual "will also be penalized for second marriage if the Arbitration Council does not permit it in spite of the approval by the first wife". The IHC also multified the decision of an additional session judge

Mir in the same case. The aforementioned person married Dilshad Bibi in 2011. Mir performed a second marriage in 2013 without the consent of his first wife as well as the Arbitration Council. He was handed over one-month jail sentence by an Islamabad magistrate for his offens and was fined Rs5,000.

An additional session judge released Mir afterward on the grounds that he was a native of Azad Kashmir. The Islamabad High Court – after annulling the decision – said in its remarks that all laws are applicable to the person who possesses the national identity card. The second marriage is registered in Islamabad and the court holds the authority to conduct its hearing, the IHC declared.

Intelligence Bureau's (IB) former director general, Aftab Sultan, on Monday appeared before the Na-Accountability Bureau (NAB) to record his statement in an investigation into bulletproof vehicle case. Sultan appeared be-fore NAB's Rawalpindi chapter to record his statement after being summoned by the anti-graft watchdog body. Former prime ministers Nawaz Sharif and Shahid Khaqan Abbasi have already recorded their statement in the case. According to the NAB 34, bulletproof vehicles were pro-cured from Germany for the guest of the South Asian Association for Regional Cooperation (SAARC) conference. The vehicles were bought without paying import

duty, it added.

The official further told that police had regis-


tered an FIR; however, the FIR was registered against only one person named Rana Ahsan Khan, a copy of which available with Pakistan Today.

### Court seeks challan in China bride trafficking case

## China-Pakistan traffickers force brides into prostitution

At first, in her desperate calls home to her mother in Pakistan, Natasha Masih could-n't bring herself to say what they were doing to her. All the 19-year-old would say was that her new husband — a Chi-nese man her family sold her off to in marriage — was torturing her. Eventually she broke down and told her mother the

full story, pleading with her to bring her home. The husband had hidden her away in a hotel in a remote corner of China and for the past weeks had been forcing her

to have sex with other men. "I bought you in Pakistan," she said her husband told her. "You belong to me. You are my property." Her mother turned to the only people she knew who could help, her small evangelical church in a n-down slum of the Pakistani city of



Faisalabad. There, a group of parishioner began putting together an elaborate plan to rescue the girl from the hotel more than 1,100 miles away. Natasha was one of hundreds of Pakistani girls who have been married off to Chinese men in return for cash payments to their families, most of them Christians, a community that is among the poorest of the poor in the country. The Associated Press reported previously how Christian pastors and Pakistan and Chinese brokers work together in a lu crative trade, aggressively pursuing Pak-istani girls who are tricked into fraudulent marriages and find themselves trapped in China with sometimes abusive husbands.

Since then, police investigations have uncovered that many of the women are forced into prostitution in China. A picture of the extent of the trafficking net-works has emerged from a series of arrests and raids in recent weeks by Pakistan's Federal Investigation Agency, as well as testimony from victims, many of whom were previously too frightened to come forward. The AP spoke to seven girls who had been forced into prostitu-tion — four of them still in China.

Families are told their daughters will be wed to well-off businessmen and given good lives in China, and the marriage trade is depicted as a benefit for all sides - impoverished parents receive money, while Chinese men find brides in a country where men outnumber women. But investigators are increasingly convinced that the majority of the girls are sold into prostitution, two law enforcement officials familiar with the investigations told the AP.
"The girls who are interviewed say they were tortured" - using a euphemism for rape and forced prostitution, said one of the officials. "They are afraid for their families and for the disgust they fear they will feel. ... Make no mistake, this is traf-ficking." However, even as investigators are uncovering the scope of the trade, the Pakistani government has sought to keep it quiet. Senior government officials have ordered investigators to remain silent about the trafficking because they don't want to jeopardize Pakistan's increasingly close economic relationship with China, the two officials said, speaking on condi-tion of anonymity for that reason. Beijing is investing billions of dollars

in Pakistan as part of its Belt and Road Initiative, a global endeavor aimed at recon-stituting the Silk Road and linking China to all corners of Asia. Under a \$75 billion to all corners of Asia. Under a \$75 billion project known as the China-Pakistan Economic Corridor, Beijing has promised a sprawling package of infrastructure development, from road construction and power plants to agriculture. The largest composition of the control of the con nent is a 3,200-kilometer (2,000-mile) road linking China to Pakistan's deep-water port of Gwadar on the Arabian Sea.

In Pakistan, it has been billed as a massive development program that will bring new prosperity to the South Asian nation, where the average citizen lives on just \$125 a month. Since 2015, thou-sands of Chinese have arrived in Pakistan to work on a multitude of projects. China's ambassador to Pakistan has gone on local television channels deny-ing girls are trafficked to China and sold into prostitution. The issue of human trafficking was not discussed during a visit to Pakistan this month by China's vice president, Wang Qishan, who held talks with Prime Minister Imran Khan and Pakistan's president.

#### WAR ON THE ROCKS

O generals matter? Well, of course they do, on some level. But do they matter as much as military history suggests they do, or as much as most people believe? In thinking about generalship and outcomes while writing Alhare of Battle: A History of How Wars Have Been Won and Lost, I was surprised to come to the conclusion that generals matter far less in the history of war than is usually represented in traditional military history. This is especially true of those generals praised by military historians as ge-niuses of maneuver warfare. Superior generals may win a tactical or operational victory by overmatching an opponent in a day of battle or a campaign, but in the protracted fighting that marks major wars among modern nations and coalitions, they do not deliver strategic victory.

I didn't always think that. I was impressed by histories of spectacular battles and brilliant car paigns said to be obvious fulcrum moments in war the ones where a genius on horseback found a ay to maneuver past stone borders, to isolate a plodding enemy army and defeat it in battle on a red day or in a summer campaign. Those rare, and rari-fied, "Great Captains" of history whose military ge-nius stand as exemplars for all times and wars, and whose close study and emulation Napoleon recom-mended as "the only means of becoming a great cap-tain, and of acquiring the secret of the art of war." The timeless generals who changed the face of war for our time with a unique coup d'oeil and highly aggressive tactics that historians and theorists celebrated ever after.

We have all read the too-common histories wherein even the failed heroic on offense beats stoic defense every time, at least in military his-tory's assignment of command "genius" to dead generals. Histories in which ladled praise tells us how wars should be fought in imitation of the "Great Captains," ancient or modern, even if wars are lost, instead of telling us how they are fought by those who win.

We are all familiar with nationalist military his tories in which armies are led to mass slaughter, yet scholars declare Marlborough the finest of English generals. Or in which Prussia is wrecked and Fred-erick contemplates suicide, saved only by a stroke of fortuna, yet he is the greatest of Germans. We have all perused bookshelves stacked with adulation wherein France fights for a generation only to lose and be left in ruins, twice, yet an age is named by historians for Louis XIV and another for Napoleon.

What I found more interesting, more telling about real-world outcomes, is the far greater number of generals and armies that never tried for, or outright ided, the modern ideal of Clausewitzian climactic battle. These generals knew they could not achieve battie. These generals knew they could not achieve it, or were not allowed to try — either by nations and empires afraid of losing their capability to a superior enemy, or just to vanity in the saddle of the man in command of their own army. More often, the win-ning side in modern wars understood that the operational doctrine of the modern aggressor, offensive maneuver warfare heading to the decisive battle, was not suited to the policy or interests of a status quo power. Nor was battle-seeking actually decisive in prolonged strategic contests between great powers or empires, or opposing coalitions provoked into exis-tence by the opening rounds of fighting. Tactical and operational dexterity almost never brought the promised strategic victory as quickly as proponents prom-ised, or at all. Instead, it descended into coalition war destined to be decided by attrition, or to be fought over and again under different names, res generational pauses to recover and rearm. Clausewitz recognized this more limited and endless character of real war late in life, but he never resolved the clash between history and his younger self's theory and idolatry of battle and of purported "military genius."

## **DO GENERALS MATTER?**

### I WAS SURPRISED TO COME TO THE CONCLUSION THAT GENERALS MATTER FAR LESS IN THE HISTORY OF WAR THAN IS USUALLY REPRESENTED IN TRADITIONAL MILITARY HISTORY

Wiser leaders, less aggressive ones, the ones more likely to win, told their armies to sit behind stone walls or a riverine defense, behind 18th-cen-tury fortified frontiers, inside 19th- or 20th-century trenches, accepting acceleration of attrition that intermittent battles delivered instead of decision. They said to their generals, "avoid rather than seek decisive battles. Let the aggressor recklessly smash his legions and expend his national treasure against my strong, defensive positions." Winning nations endured defeat after defeat but kept fighting, while activating latent military resources and assembling a grand coalition to wage a long war that blunted the short war delusions of the aggressive power that started it all. They did not always win: War is too contingent and complex to predict or perfect. But they won far more often than highly offensiveminded aggressors, deluded that in decisive opening campaigns and battles of annihilation, in their own operational or national genius, lay a short-war solution to decades of unresolved geostrategic is-

Attrition is not the only reason modern wars are won and lost. There is no one thing that guarantees victory or defeat in the most complex of all human activities. But one deep pattern in history is that victory goes more often to those who resist the allure of battle, which blinds us to the deeper reality of great power strategic balance, and hence to the far greater likelihood of bogging down in long wars of attrition. More wars are won by digging in and enduring, by grinding rather than by genius, by hanging on after initial defeat to recover and fight the slow war that defeats the short-war delusion of aggressors. Defen-sive strategy, and with it acceptance of the necessary role of attrition in the final outcome, has won far more often than reliance on operational brilliance. Endurance of defeat, recovering to fight on, tapping into long war acceptance of attritional outcomes, has more often won than lost. Attrition stymied aggres-sors (and would- be liberators) who rolled the iron dice hoping for a short war, who crossed a border looking to win fast in a great and decisive battle or campaign, only to tumble their nation into long and losing wars of moiling resistance.

Military history and theory are still burdened by an offensive bias. We need to better understand those who made war within the real limits of their time rather than seeking to overcome and redefine war for all times. Accepting the limits of one's era, fighting within its technological and cultural constraints, matters a great deal. Humility about the possibilities for offense and the strengths of defense matters very much, whether what one must overcome is stone and cannon, slow fortification by long sieges, or complex trench systems supported by modern artillery, but far more importantly by the activated resources and committed will of whole nations and empires. This is what ensures attrition, rather than doctrine, decides most wars. We should look past the handful of generals who sought to impose their will or the aggres-sive will of their nation with clever projects for short offensive war. If we are to understand the major factors that actually decide victory and defeat in most modern wars, we should study spectacular plans and offensive doctrine less, and the capacity for en-

durance and acceptance of attrition more.

Ignored and indeed belittled in traditional military histories are the many successful generals who fought their opponents to a stalemate because defense and not aggression was their mandate. Military history, or at least military historians, have tended to favor the bold, aggressive few over the more odding, but often more successful, many. Histori-is too often pointed to strings of battles as the deplodding, but often m cider of wars instead of exploring the deeper complexities and contingencies of war, which are its greater truths. Why is there this deep bias toward offense over defense in military history? One reason is the aesthetics of war, the "lust of the eye" and raw excitement that accompanies any battle. The sheer spectacle of a grand battle seduces many military historians and military theorists, governments and generals, aroused nations, and people who buy books and watch war movies. Attrition does not pivot war on the fulcrum of genius the way battles too often wrongly are said to have done. We despise it as morally vulgar, without redemptive heroism We fear we will find only indecision and tragedy without uplift or morality in the trenches and roll calls of dead accumulating over years of brutal effort and endurance. So we elevate battles to summits of heroism and generals (and admirals) to levels of ge-

nius that real history cannot support.

Bluntly stated, we should accept the grim reality that victory in modern major wars was most often achieved by mass slaughter, not by heroics or the ge-nius of generals. Winning at war is much harder than winning in battle. Cannae, Austerlitz, Tannenberg, and Kharkov were all hugely lopsided battles that did not ensure victory in war. Hannibal won at Can-nae, Napoleon won at Austerlitz, and Hitler won at Kiev and in many other battles from 1939 to 1941. Then all proceeded to lose the wars they started and catastrophically.


While there is much heroism in battle, usually on all sides, there are no geniuses in modern war. And even if there are, war is too complex even for a genius to control. All the rest, the parlor game of com-paring generals' reputations, or elevation of one tactic (say, redcoat musketry over French heavy column), descends into armchair idolatry divorced from umn), descends into armchair idolatry divorced from real explanation of victory and defeat. This explana-tion comes from long-term preparation for war, from strategic capacity to absorb defeats and endure suf-fering, from waging war with national resources marshaled by modern bureaucracy, from effective

domestic propaganda and management of morale.

Major wars are won by strategic depth and aroused long-war resolve, whether natural to self-defense or whipped up by the modern state. Those fac-tors are far more important than any general or admiral, even clearly superior ones. Strategic depth and resilience are what made Rome militarily dominant for centuries, saved Tsarist Russia in 1709 and again in 1812, sustained France in 1914, Britain after 1940, the Soviet Union in 1941, and let the United States win in the Pacific rapidly and certainly. Mas-sive, early defeat of an enemy's army in a great, "de-cisive battle" did not avail Carthage in the Punic Wars or England in the Hundred Year's War. Early victories did not bring final victory to overmatched France by 1815. Success in the east in 1914 did not rescue hubristic Imperial Germany from defeat in the west in 1918. Two years of uninterrupted triumph by overstretched Nazi Germany from 1939 to 1941 only delayed the foreseeable catastrophe of 1945, while making the war both then and now look more strate-gically even than it ever was. The spectacular success of overreaching Imperial Japan in the opening months of the Pacific War did not prevent total war defeat across the entire military spectrum in 1945.

All these losers of major wars lost because the overestimated their own operational dexterity (and often, also laid a claim to superior moral or even spiritual virtue), and underestimated the strength of their enemy's defensive capabilities and resolve. Then they failed to overcome their opponents' strategic depth, capacity for recovery, and willingness to ac-cept attrition until the tide of war reversed. Winners absorbed defeat after defeat yet kept fighting until they overcame initial setbacks in battle to win by more effectively mobilizing their societies, by form-ing defensive coalitions, by committing to drawn-out wars of material and moral forbearance

I suspect the deepest problem in the way of our derstanding modern war is very old-fashioned: vanity. The vanity of civilian elites who make shortterm policy and call it long-term strategy. The vanity of generals (and admirals) who implement flawed or inept war plans knowing the means they have cannot eve the goals for which they reach. The vanit of nationalists and historians (too often one and the same) who misrepresent how wars actually are won



and lost, so that the old pattern repeats. But abo all, the vanity of nations and empires. All that pride in our short-war capability, our superior moral virtue, our sublime doctrine and the fighting quality of our army (or navy, or air force), cometh before a fall into unplanned wars of attrition. Civilian leaders promise too-eager publics a "short and lively" (kurtz und vives) war, hand off the problem to their military, then are surprised by and lament a rough parity among the great powers that conduces to protracted war. This is one of the major patterns of history that ensured long wars of attrition followed from short war delusions, including, after 1945, proxy guerilla

A national policy accepting protracted war as in-escapable is not pretty or exciting, or flattering to military chauvinists of any country. They would rather assume their side's operational or cultural or historical or racial superiority to the enemy, cleaving to the short-war delusion, rather than reconsider whether the goals at stake are worth the attritional war that is surely coming. And so the allure of battle persists, and we all walk along the knife's edge in the latest crisis of cultural vanity in the Middle East, or Kashmir, or the Koreas, or the Strait of Hormuz, or me as-yet undeveloped and undiscovered locale of future crisis and war.

As I have come to admire defensive warfare more and offensive warfare less, I discovered a sec-ondary theme laced throughout military history that irks. At least since Clausewitz, the idea of "military genius" is comparably prevalent in too much military theory. Too many historians point to asserted rather than defined genius (usually in a not-so-hidden nationalist form) as decisive in war instead of explain-ing how a given war actually was won or lost by logistics and finance, or by advanced bureaucracy and mobilization of national resolve. Among military professionals we have seen nearly two centuries of effort to capture the sunbeam of command genius and bottle it, from eternal "principles of war" to gen-eral staff planning and officer training, to doctrine based on reams of "lessons learned." Let us leave aside talk about military genius as it pertains to gen-erals and decision in and by war. It is wrongheaded, superficial, and ultimately distracting from what is far more important. We need to reassess military his-tory and operational doctrine that can flow from it. We need to better understand those who made war within accepted limits, rather than always praise those who sought to overcome the limitations of war with the lives of young men, and now young women, too, spent like pennies to service the vanity of their leaders and their nations.

Will we do it? Two summers ago, a variety of ior, active duty, and highly thoughtful American senior, active duty, and highly thoughtful American officers and civilian planners gave me a formal briefing. I asked one group if they would accept that, after the initial crushing of the Taliban and "thunder run" into downtown Baghdad, we are now engaged in a new Thirty Years' War of protracted attrition in the few Inity Years war or protected attrition in the Greater Middle East. Many heads nodded affirma-tively, So I asked if they would accept that it could become a Hundred Years' War. The question did not shock them, and again many in the room agreed it was possible. In a smaller briefing the next day, a supremaly competent them. supremely competent, sharp-as-a-knife colonel de-livered "lessons learned" by the U.S. military in Afghanistan and Iraq, I rather too cheekily asked: "Have you learned any lessons?" He replied, without missing a microsecond, "We have. The politicians

## POMPEO HEADS TO SAUDI ARABIA, UAE **FOR IRAN CRISIS TALKS**

US Secretary of State Mike Pompeo said Sunday he will visit Saudi Arabia and the United Arab Emirates for talks on the cri-sis sparked by Iran's downing an Ameri-

"We'll be talking with them about how to make sure that we are all strategically aligned and how we can build out a global coalition" on Iran, he said. Iran shot down a US Global Hawk

drone on Thursday, saying it had violated its airspace near the strategic Strait of Hor-muz — a claim the United States denies.

US President Donald Trump called off a planned retaliatory military strike Friday, saying the response would not have been "proportionate," with Tehran warning any ack would see Washington's interests

Pompeo said he would stop in the two countries on his way to India, where he begins a visit on Tuesday.

Speaking to reporters as he left Washington, Pompeo called Saudi Arabia and United Arab Emirates "great allies in the challenge that Iran presents.'

Pompeo denounced a map that was re-leased by Iranian Foreign Minister Mo-hammad Javad Zarif that purported to show a spy drone encroaching its airspace in late May and urged media not to find it

"You've seen that child-like map that Foreign Minister Zarif put out that contrasts with the excellence and profession alism of America's military intelligence services," Pompeo said.

Pompeo said that Iran's map "should leave no doubt in anyone's mind about flying in international airspace."
"We shouldn't let the Iranians have

one moment where any reporter would write that there is even a credible response to the data set that the Americans have put forward," he said, accusing Iran of "sowing disinformation in lots of lots of

But Pompeo reiterated Trump's offer of dialogue to improve relations with Iran, which the US administration has sought to isolate through harsh sanctions.

"We're prepared to negotiate with no preconditions. They know precisely how to find us," Pompeo said.

"And I am confident that at the very

moment they're ready to truly engage with us, we will able to begin this conversa-tion," he said. "I'm looking forward to the day," he added.

## US, Taliban aim to firm up date for foreign force exit from Afghanistan

Upcoming peace talks between the United States and the Taliban will focus on working out a timeline for the withdrawal of U.S.-led troops from Afghanistan and on a Taliban arantee militants won't plot attacks from Afghan soil, sources said on Monday

A seventh round of talks between the warring sides begins on Saturday in Qatar's capital of Doha, where U.S. and Taliban negotiators have been trying to hammer out a deal to end to the 18-year-long war since October. "Once the timetable for foreign force withdrawal is announced, then talks will automatically enter the next stage," said Sohail Shaheen, a spokesman for the Taliban's political office in Doha.

"We don't need to wait for the completion of the withdrawal, both withdrawal and talks can move for-

ward simultaneously." The focus of the talks has been a Taliban demand for the withdrawal of U.S. and other foreign forces and a U.S. demand the Taliban guarantee that Afghanistan will not be used as a base for militant attacks.

Two other main issues in the

process are a ceasefire and talks between the rival Afghan sides - the in-surgents and the Western-backed government. But the Taliban have long refused

to talk to the Afghan government, de nouncing it as foreign "puppet", and fighting has seen no let-up. Two other sources with knowl-

edge of the talks said the sixth round in May ended with unease on both sides, but since then informal meeting had taken place to work out what

can be agreed on.
The U.S. special envoy for peace

in Afghanistan, Zalmay Khalilzad, has also held informal meetings with the Taliban leadership in Doha. "Based on my recent visits to

Afghanistan and Qatar, I believe all sides want rapid progress," Khalilzad said on Twitter.

Khalilzad, an Afghan-born American diplomat has been leading the talks to secure a political settlement with the hardline Islamist group that now controls more Afghan terri-tory than at any time since being toppled in 2001 by U.S.-led forces

About 20,000 foreign troops, most of them American, are in Afghanistan as part of a U.S.-led NATO mission to train, assist and ad-vise Afghan forces. Some U.S. forces carry out counter-terrorism opera-

At least 3,804 civilians were killed in the war last year, according to the United Nations. Thousands of Afghan soldiers, police and Taliban were also killed.

Nevertheless, the Taliban leader wed this month to sustain the fight until their objectives were reached.

In March, a draft agreement was reached on the withdrawal of foreign forces in exchange for a commitment by the Taliban to cut ties with mili-tant groups such as al Qaeda. A Taliban source said both sides

were expecting some clarity and re-sults on the prime issues in the new round talks.

"A ceasefire and intra-Afghan talks will not be discussed during the seventh round," said the Taliban source, who declined to be identified.

Some Afghan government offi-cials side fear the United States and the Taliban will strike a deal on the withdrawal of foreign forces, en-abling the United States to get out of an unpopular war but leaving gov-ernment forces to battle on alone.

#### 7.5 magnitude earthquake hits Indonesia

JAKARTA: An earthquake of magnitude 7.5 struck in a remote area of Indonesia in the Banda Sea on Monday, the US Geo-logical Survey (USGS) said, but there were no initial tsunami warnings. The quake hit at a depth of 136 miles, the USGS said. There were no immediate reports of damage or injury. The Hawaii-based Pacific Tsunami Warning Center said in a bulletin a destructive Pacificwide (sunami was not expected after the quake, which was initially recorded with a magnitude of 7.2. AGENCIES

#### **Bangladesh train** derailment over canal kills five, injures 100

DHAKA: A passenger train derailed in Bangladesh on Monday, killing at least five people and injuring more than 100, and there could be more casualties inside two carriages that fell into a canal, a police officer said. The train was cro bridge on its way to the capital, Dhaka from the eastern city of Sylhet when it went off the rails, police superintendent Mohammad Shahjalal said. He said there could be more bodies in the carriages that were submerged in the canal, he said. The derailment occurred near the Moulavi Bazar district, 130 miles east of Dhaka, AGENCIES

### Yemeni rebel attack on Saudi airport kills one, wounds 21

A Yemeni rebel attack on a civilian airport in southern Saudi Arabia killed a Syrian national and wounded 21 other civilians on Sunday, a Rivadh-led coalition said, in a new escalation following a series of strikes on the site.

The attack on Abha airport, which the coalition said left a McDonald's outlet at the site littered with shattered glass and damaged 18 vehicles, comes amid spiral-

ing regional tensions with Iran.

The escalation of attacks by Iranaligned Huthi rebels on Saudi cities threatens a hard-won UN-sponsored ceasefire deal for the Red Sea port city of Hodeida, war-ravaged Yemen's main conduit for humanitarian aid.

conduit for humanitarian aid.
"A terrorist attack by the Iran-backed
Houthi militia on Abha airport... killed
a Syrian resident and wounded 21 civil-ians," the coalition said in a statement
carried by the official Saudi Press

Agency.

The wounded — from Saudi Arabia,
Egypt, India and Bangladesh — also included three women and two children who had been taken to a hospital for treatment, the coalition said.

It did not provide details on how the airport was attacked, but Houthi rebels have repeatedly struck the civilian facility this month with drones and missiles.

Earlier on Sunday, the rebels' Al-Masirah TV said they had targeted Abha and Jizan airports in the south of the kingdom with drones

The coalition did not confirm the attack on Jizan airport.

Abha airport authorities said on Twit-ter that air traffic had resumed and oper-ations were running normally, without

saying how long they were disrupted. On June 12, a rebel missile attack on Abha airport wounded 26 civilians, drawing promises of "stern action" from the coalition.

Human Rights Watch denounced the

strike as an apparent "war crime", urging the Houthis to immediately stop all at-tacks on civilian infrastructure in Saudi

The latest raids come amid spiraling regional tensions after Washington — a key ally of Riyadh — accused Iran of shooting down a US drone and carrying out attacks on oil tankers in the strategic Gulf of Oman.

Saudi Arabia, the United Arab Emirates (UAE), Britain and the US, in a joint statement published on Saudi state media on Sunday, voiced alarm over escalating regional tensions and the "dangers posed by Iranian destabilizing activity". Saudi Arabia has repeatedly accused Iran of sup-plying sophisticated weapons to Houthi rebels, a charge Tehran denies.

## Palestinians rally against Kushner's economic peace plan

Palestinians burned portraits of President Donald Trump as they protested in both the Gaza Strip and the Israeli-occupied West Bank on Monday against U.S.-led plans for a conference on their economy

Many Palestinian business group have said they will boycott the June 25-26 event, billed as part of Washington's long-awaited Israeli-Palestinian peace plan and spearheaded by Trump's adviser and son-in-law Jared Kushner.

"Down with Bahrain, down with Trump, down with the Manama confer-ence," chanted crowds in Gaza, which is ruled by the armed Islamist group Hamas. Some burned large paintings of Trump marked with the words: "Deal of the

Leaders in both territories have accused Washington of pro-Israel bias and railed against the conference's focus on ics, rather than their aspirations

Kushner told Reuters on Saturday the plan would create a million jobs, halve Palestinian poverty and double the Pales-tinians' GDP.

In the West Bank, hundreds marched through Ramallah's main squares, waving posters in support of President Mahmoud Abbas, whose Western-backed Palestinian Authority exercises limited self-rule in the territory.

Protesters there burned posters of both Trump and Bahrain's King Hamad bin Isa Al Khalifa.

The rallies marked a moment of political unity against the Bahrain confer-ence, despite a 12-year political feud between Abbas's Fatah party and Hamas. 'A WEDDING WITHOUT THE BRIDE': "The Manama conference is a comedy show, a wedding without the bride (the Palestinians) ... it will not succeed," said a protester who gave her name as Siham in Gaza City. The Bahrain conference will be at-

tended by Gulf Arab states as well as Jor-



dan and Egypt. Israel is expected to send a business delegation but no govern

officials.

Mahmoud Barhoush, 25, said he did-

n't know whether to laugh or cry at what he called Arab states' "treasonous" par-

ticipation.

### **Pak-Qatar economic relations**

#### Where is the mega Qatari investment?

N January, PM Imran Khan visited Doha as the head of a delegation to discuss economic cooperation with the Emir of Qatar, Following the premier's visit, the Board of Investment organised a Pakistan-Qatar Investment Forum between the business communities of the two countries. In April Qatar Investment Authority head Sheikh Faisal Bin Thani Al-Thani came to Islamabad to hold talks with Adviser to PM on Commerce Abdul Razak Dawood and BOI Chairman Haroon Sharif. The Qatari official was told about the fields wherein Pakistan would welcome investment. A cautious Sheikh Faisal however made it clear that Qatar was looking for a long-term partnership and not "quick wins." Interestingly Asad Umar and Haroon Sharif, the two major figures closely related to talks with Qatar were made to leave the govern after eight months creating questions about the

continuity of government's economic policies.

One wonders which one of the several advisers fed the idea to PM Imran Khan that Qatar was itching to outbid the Saudi Crown Prince MBS by investing more than \$ 21b in Pakistan. Khan is no doubt keen to bring good news to the people of Pakistan in general and the PTI followers in particular who are thirsting for it. This leads those around him to feed stories based on hopes, expectation and miracles thus causing embarrassment to the PTI chief. Not long ago, the PM expressed the hope that Pakistan was on the verge of hitting the jacknot by covering a huge reserve of oil and gas in the Arabian Sea

Qatar is keen to develop alternate sources of food and items of daily use after the blockade imposed by Saudi Arabia and UAE. This has helped India and Pakistan increase exports to Qatar. Qatar also signed three MoUs with Pakistan on Saturday on trade and investment, cooperation on financial intelligence and tourism. There are expectations of more Pakistanis getting jobs as preparations for World Cup Football are speeded up. Although Qatar has agreed to extend a loan to Pakistan like Saudi Arabia and UAE, any large investment is contingent on improvement of business climate. A lot will have to be done before any big foreign investment is committed in Pakistan.

part from setting a record high tax collection target another focus in the first federal budget tabled by the PTI is austerity; a combination of reducing expenditures and increasing revenue is the plan to get the country back on its feet. One of the most notable contributions to this belt-tightening was the Armed Forces taking a voluntary cut in their allocated expenditure by refusing the routine increase in the defence budget. Considering the economic condition of the country it was a reasonable decision that would not only support the government in its efforts to plug the revenue-expenditure gap but also in terms of optics, displaying that every institution was doing its part. However, the Finance Ministry has now informed parliament that a total of Rs222 billion were spent by the overnment without parliamentary approval of which Rs36 billion was spent by the army making it the recipient of the largest supplementary grant last year. In addition to this the documents also reveal that apart from an increase of 1.4pc over the revised defence budget figure (Rs1.138tr to Rs1.152tr) a separate 'developmen expenditure' for the defence division of Rs370.5bn for the upcoming fiscal year translates into a combined increase of 21.5pc in defence spending over last year.

A discrepancy of this magnitude requires explanation on part of the government. If there is misreporting of figures now, it is the government's responsibility to provide an acceptable clarification. If in fact the budget cuts were initially part of the plan and there was a revision later then it again falls upon the government to explain why such a reversal was necessary. PM Khan himself through his twitter account lauded the proposed expenditure cuts in the defence budget and promised that the funds would be spent on development in Balochistan and FATA. Details that are now being reported suggest otherwise. Given the regional threats that the country faces, especially the recent escalation with India, any proposed increase in the army's budget can be justified. But it would be best that some rationale is presented by the Finance Ministry in relation to these updated budget allocations otherwise an unnecessary controversy will unfold very quickly.

## Transformation of Pashtun culture

#### Through misrepresentation and biases

HE cultural landscape of Pashtun society has undergone more drastic changes during the last few decades than ever before due to the fast changing geo-strategic, geo-political conditions and globalization in the region. The area has become the battle ground for world powers which has af-fected the overall social structure of the society.

Firstly, the collective centers of culture that held the Pashtuns strongly connected were tar-geted by the colonizers, the British Empire with peculiar oppressive laws when they were ruling over the sub-continent. Secondly, after independence, excessive religiosity of the typical mullahs has targeted the creative arts and healthy activities

in the region.
Thirdly, under the Zia regime of Islamization and Afghan war had changed the entire land-scape of the Pashtun culture - replaced the scape of the Pashtun culture - repracts use Pashtu literature with Jehadi stuff of literature, pens with weapons, and musical instruments with loud speakers. Afterwards, the militant groups started targeting the artists (musicians and singers) and the art centers along with historical

sites of heritage and tombs of saint poets.

Islamization in the society was followed by 
'Talibanic version of Islam' and their worldviews. Thus after radicalization of madrassah

students with 'Jehadi narrative', their approach turned towards forceful assertion of religious teachings in public domains. Resultantly, the society was introduced to the kalashinkove culture. It has also witnessed imposition of Sharia law with extreme acts of violence. Likewise, media has also generalized and shaped the identity of the community more with the approach of racial profiling – militants wearing typical Pashtuns' dress with turban. In the post-9/11 scenario, terrorists were identified and generalized with Pashtun and vice versa - almost all of the cultural peculiarities of Pashtuns were attached to the terrorists.

The community has suffered and still continues to suffer in reaction to Talibanization and terrorism – a number of military oper-ations were launched to address the issue of rising militancy in the area has turned a large part of the community internally displaced. Consequently, their businesses destroyed, infrastructure dismantled. and their cultural institu-tions and entertainment activities have affected to a

The concept of collective and social lifestyle with unique cultural institutions of the community: *Hujra, Jirga, Nanawati*, collective sense, celebrations, traditional and social events were also criticized both by the religious

orthodox and modernists.

The religious seminar-ies whose number multi-plied in the wake of the Afghan war in the Pashtun dominated areas were de-fended and supported by the leaders of religio-political parties who failed to under-stand the international game being played in their areas by the world powers. However, throughout

the nationalist progressive political parties remained loyal to the land and its people in their narrative against the foreign onslaughts on Pashtun culture. As a result, they had also suffered the brunt of terrorism more than others in the region.

The collective memories about the great Pashtun heroes and their deeds of bravery against the oppressors and colonizers have al-most washed away along with the old

generation. The Pashtun are actually different from the way they have been presented to t world - they are more misrepresented like Mi lims in the western world.

## Netanyahu's defunct strategy to keep Hamas at bay

One violent episode after another

ETANYAHU has served as prime minister for the past 11 years, coinciding with Hamas' rule over Gaza ever since it usurped power in 2007 from the Palestinian Authority after a brief violent confrontation between the two sides. During this period, Netanyahu has deliberately perpetuated the conflict with Hamas as a means by which to promote his sinister political agenda. At no point has he contemplated finding a mutually acceptable solution that could end the hostilities and gradually lead to peaceful coexistence. Instead, he has portrayed Hamas as an irredeemable foe committed to Israel's destruction, insisting there is nothing that Israel can do other than maintain the status quo and handle Hamas with force.

The recent flareup between the two sides is judges another violent episode in a continuing bloody conflict, including three wars that killed thousands of Palestinians and scores of Israelis, not to speak of the massive destruction inflicted on Gaza and the social and economic dislocation that the Israelis endured.

Netanyahu often uses disproportionate force to 'teach Hamas a lesson'. He knows, however, that the humanitarian crisis in Gaza is of such magnitude that it is impossible for Hamas and the public to accept, as in the past, incremental and temporary relief while the blockade remains in place and hopelessness and despair continue to reign. Predictably, the vicious cycle of violence continues, and managing rather than solving the conflict has been Netanyahu's strategy all along.

Netanyahu is resisting calls from his own party, as well as from some of the opposition members, to invade Gaza and decapitate Hamas' leadership—as Energy Minister and Security Cabinet member Yuval Steinitz described it to Army Radio on Monday, "to get rid of Hamas, we have to conquer Gaza." He and others foolishly believe that such a drastic move would guarantee calm and lead to a peaceful transition from Hamas to the PA, which is nothing short of a pipedream. Unless Israel occupies Gaza permanently, a new cadre of Hamas leaders will rise almost overnight who will be even more militant and resilient than the current leadership.

Netanyahu objects to another incursion, fearing that this time Hamas will not agree to any ceasefire that does not permanently provide relief and lead to the lifting of the blockade, which he vehemently opposes.

He also refuses to reoccupy Gaza, as this would force the Israeli government to care for nearly two million Palestinians, which would be nothing short of a nightmare. Not only would such an ill-conceived move require the establishment of a massive security apparatus that will constantly put the lives of soldiers at serious risk, it would also cost hundreds of millions of dollars annually to sustain.

Netanyahu has constantly strived to prevent any reconciliation efforts between the PA and Hamas, which allows him to claim that there is no negotiating partner. And when the PA and Hamas have agreed twice in the past to form unity government, Netanyahu refused to enter peace talks, insisting that he won't negotiate with a Palestinian government that includes Hamas. Netanyahu often accommodates the Egyp-

tians in dealing with Hamas, given Egypt's important role in mediating between Israel and Hamas. Egypt is interested in maintaining calm in Gaza, but does not mind the punsing blow that Israel frequently inflicts on Hamas. As Hamas is an off-shoot of the Muslim Brotherhood, which Egypt has designated as a terrorist organization, it imposes serious restrictions on the crossing of Palestinians from Gaza into Egypt.

Finally, Netanyahu

Finally, Netanyahu consistently opts to maintain pressure on Hamas by seizing any opportunity to interrupt the flow of goods and building materials to ensure that Hamas remains

ensure that Hamas remains vulnerable and dependent on Israel's goodwill. He wants the Palestinians in Gaza to blame Hamas and Islamic Jihad for their plight, hoping to instigate unrest—which has not materialized in any significant way. He skillfully led the majority of Israelis to believe that Hamas is a mortal threat while ignoring the irreversible facts on the ground, which he must face in order to find a permanent solution to the conflict with Hamas.

Gaza is in effect a large open-air prison with nearly two million destitute Palestinians that cannot be wished away. Gaza is territorially separated from the West Bank and is governed by Hamas, which embraces a different ideology than the PA. There is no prospect that the PA and Hamas will reconcile their differences, Hamas will not relinquish power and surrender their arsenals to the PA, which, from its perspective, is tantamount to capitulation. Hamas priority is to end the Gazans 'imprisonment' and it will continue to fight and sacrifice to achieve an end to the blockade.

It should be made clear though that Hamas

It should be made clear though that Hamas has been its own worst enemy. Even though it knows Israel is here to stay and no power can dislodge it, it openly calls for Israel's destruction, which plays directly into the hands of Netanyahu and a majority of Israelis. Hamas' militancy and buildup of military arsenals provides further proof to many Israelis that Hamas is an irredeemable enemy that deserves what has befallen it.

The validity of this argument, however, does not change the reality that the Palestinians in Gaza are largely living under subhuman conditions. And regardless of Hamas' bellicose narrative against fiszed, it too wants to end the conflict without being humiliated in the process. The solution to the conflict with Hamas is not another incursion into Gaza, or raining destruction from the air, or decapitating Hamas' leadership, and certainly not re-occupying Gaza. Instead, Israel needs to treat Gaza as a separate entity from the West Bank, as there is hardly anything in common between the two sides.

Hamas has proposed time and again a long ceasefire (Hudna) for 15-20 years, during which Israel would allow Hamas to embark on

building infrastructure, housing, hospitals, schools, scaports, and other development projects. This would create thousands of jobs and an improved quality of life that every Palestinian in Gaza yearns for.

These projects should be implemented under the supervision of a special international commission to ensure that all funds raised from donor countries, including the US, the EU, and the oil-rich Arab states, are channeled to these projects. Hamas would certainly develop a vested interest in safeguarding the new development, and would therefore refrain from provoking Israel, and

from provoking Israel, and rein in Islamic Jihad to maintain the calm. Hamas knows that Israel will always be able

Hamas knows that Israel will always be able to wreak have on Gaza should it not fully adhere to the terms of the ceasefire. A long-term ceasefire in conjunction with confidence-building measures will certainly change the nature of the bilateral relations between Israel and Hamas, which could gradually lead to lifting the blockade altogether. Furthermore, a resolution to the conflict between Hamas and the PA can and should take place, provided that it will not in any way undermine Israel's national security, affects its perfared conflict with the PA.

There are many cynics who believe that peace between Israel and Hamas is nothing but an illusion. On the contrary, anyone who maintains that the current situation is sustainable is misguided, as they ignore both the turmoil and the bloodshed over the past 12 years, and the reality on the ground that cannot be changed.

## ETHIOPIA MOURNS AFTER ARMY **CHIEF, TOP OFFICIALS KILLED**

HE death toll from two attacks believed linked to an attempted coup in Ethiopia's northern Amhara state rose to five on Monday, as flags flew at half-mast on what was declared a national day of mourning. Police were hunting for Amhara's se-

curity chief Asaminew Tsige, accused of masterminding an attack on the leaders of the state and suspected of playing a part in the killing of the country's army chief in Addis Ababa

The attorney general of Amhara state, Migbaru Kebede, died of gunshot injuries from the attack on Monday, state broad-caster EBC reported, making him the fifth victim of the violence.

The unrest has delivered another major challenge for Ethiopia's young Prime Min-ister Abiy Ahmed, who has embarked on a series of reforms in a bid to open up the au-thoritarian state which have unleashed eth-nic tensions and bitter political rivalries.

The attacks, whose exact motives re-main unclear, began on Saturday afternoon when gunmen attacked a meeting of top officials in Amhara, the second-largest of Ethiopia's nine autonomous states. Amhara president Ambachew Mekon-

nen, who was an ally of Abiy's, as well as his adviser were killed, while Migharu suc-cumbed to his wounds on Monday after what Abiv described as an "attempted



coup" in the region.

A few hours later in an upmarket sub-urb of the capital Addis Ababa army chief Seare Mekonnen, who was co-ordinating the response to the unrest in Amhara, wa shot dead by his bodyguard. A visiting general was also killed.

Abiy's office said the killing of Seare "seems like a co-ordinated attack", how-ever there have been no further official details and observers point out that there were no telltale signs of a concerted national

A statement from his office announced that the bodyguard and other perpetrators had been arrested, while a police source on Sunday told AFP that Asaminew was still

from almost a decade in prison over a 2009

coup plot under an amnesty.

Analysts describe him as a hardline Amhara nationalist who was likely facing removal from his job over efforts to form a militia and rhetoric pushing for territory in neighbouring Tigray to be reclaimed.

He recently appeared in a Facebook video calling for civilians to arm themselves in preparation for attack

A statement read on state television on Sunday night from parliament speaker Tagesse Chafo called for the country to

a national day of mourning.

"All of us will remember the people who lost their lives for our togetherness and unity," a television announcer said, reading

"It is a sad day for the whole nation. We have lost people who were patriotic. They are martyrs of peace."

The European Union in a statement

urged "restraint from all sides of the Ethiopian political spectrum, both at national and regional levels."

The EU firmly reiterates the need for continued peaceful and democratic reforms in Ethiopia and its support to the efforts of the Prime Minister and his government in

the Prime Minister and nis government in this context," said the statement. Minister of Defence Lemma Megresa described Seare as "humble, a very good colleague, a brother", on national television on Sunday night.

The internet remained completely cut across the nation for the third consecutive day, after being severed for much of the prior week without explanation.

In the capital Addis Ababa it was a busy morning as people went about their business as usual, however security at the airport had been beefed up with the presence of special forces.

was a significant presence of federal police officers around government offices, residents told AFP

Observers have said that the killings underscore the tensions across Ethiopia sparked by Abiy's efforts since he came to power in April 2018 to loosen the iron grip of a state long run by emperors and strong

His efforts to transition from one-party state to democracy have seen him embarking on economic reforms, he has allowed dissident groups back into the country, sought to crack down on rights abuses and arrested dozens of top military and intelligence officials.

His moves have been lauded abroad but have made him enemies at home, and exactly a year ago he survived a grenade attack at a rally which left two dead.

Long-simmering ethnic tensions along the borders of the autonomous regions — divided along ethnic lines — have burst into violence, leaving scores dead and more

into violence, leaving scores dead and more than a million displaced.

Meanwhile the prospect of elections in 2020 has shaken up local politics as long-standing regional parties find themselves facing challengers to their power, while observers say there has been a surge of ethno-

The Amhara are the second-largest ethnic grouping after the Oromo, and both spearheaded two years of anti-government protests which led to the resignation of for-mer prime minister Hailemariam Desalegn.

## Turkish civil society leaders on trial over 2013 protests

Sixteen leading Turkish civil society leaders appeared in court Monday, accused of seeking to over-throw the government during the "Gezi Park" protests of 2013, in a trial dubbed an absurd sham by critics.

The group includes renowned businessman and philanthropist Osman Kavala, whose detention since November 2017 has made him a symbol of

what critics say is a crackdown on civil society.

Kavala rejected the "irrational claims which lack evidence" in his opening statement, shortly after the trial began under high security in the prison and court complex of Silivri on the outskirts of Istanbul. He is accused of orchestrating and financing the protests which began over government plans to build over Gezi Park, one of the few green spaces left in Istanbul.

The protests snowballed into a nationwide movement that marked the first serious challenge to Erdogan's brand of Islamic conservatism and

grandiose development projects.

The 657-page indictment seeks to paint the protests as a foreign-directed conspiracy with links to the Arab Spring, which, ironically, the Turkish



vernment supported

"None of these actions were coincidental... they were supported from the outside as an opera tion to bring the Turkish Republic to its knees," the

indictment says.

Amnesty International's Andrew Gardner said the trial "speaks volumes about the deeply flawed judiciary that has allowed this political witch-hu

"It is absurdly attempting to portray routine civil society activities as crimes," he said.

One of the allegations is the claim that a map

## China eyes front against protectionism at G20

China said Monday it would seek backing for free trade and multilateralism at the G20 summit this week as it denounced protectionism while it fights a tariffs war with the United States. A meeting between Xi Jinping and his Donald

Trump on the sidelines of the gathering in Osaka, Japan has fuelled hopes for a truce in the increas-ingly damaging standoff between the world's top

two economies.
"Unilateralism and protectionism has damaged "Unlateratism and protectionism has damaged global growth... undermined global value chains and dampened market sentiment," Zhang Jun, the Chinese assistant minister of foreign affairs, said at a briefing to preview Xi's attendance at the summit.

"China will work with others at the G20 to firmly uphold multilateralism and an open, rule-based global trading order," Zhang said.

But Japan, the European Union and other trad-ing partners have in the past echoed US complaints about the alleged theft of intellectual property and lack of a level playing field for foreign investors in China. Any attempts to build a united front with China will be tempered by these concerns.

Negotiations to resolve the trade war stalled last



onth resulting in both sides exchanging steep tariffs on hundreds of billions in exports.

Chinese vice minister for commerce Wang Shouwen said teams from both sides are now "di cussing the next step for communication" ahead of the Xi-Trump meeting.

The two should make compromises and any talks between China and the US have to be based on "mutual respect, equality and mutual benefit and comply with WTO rules", Wang said.

## Hong Kong activists renew protest against extradition bill

More than 100 people blocked a Hong Kong government building on Monday in protest against proposed legislation allowing extraditions to mainland China

that they want scrapped.

Hong Kong leader Carrie Lam, saying she had heard the protesters "loud and clear", this month postponed the bill that would allow criminal suspects to be sent to the mainland for trial in courts conrolled by the Communist Party.

The activists, mostly students, are de-manding the bill be withdrawn, the gov-ernment drop all charges against those arrested in recent protests and stop referring to the demonstrations as a riot, which could potentially lead to heavier jail terms. "It's inconvenient but I support it," a South African businessman who declined to be identified said of the protes at the skyscraper inland revenue buil near the heart of the financial center.

The former British colony of Hong Kong returned to Chinese rule in 1997 since when it has been governed under a "one country, two systems" formula that allows it freedoms not enjoyed on the mainland, including freedom to protest and a much-cherished independent judi-

The bill has seen millions of people, those freedoms, clog the streets in protest and plunge the city into political crisis, with many questioning the ability of Lam

The protesters plan another demon stration on Wednesday to raise awareness among world leaders attending the Group of 20 nations summit in the Japanese city of Osaka this week,



Affairs Zhang Jun said on Monday that China would not allow the G20 nations to discuss Hong Kong at the summit.

What I can tell you for sure is that G20 will not discuss the Hong Kong issue. We will not allow G20 to discuss the Hong Kong issue," Zhang said. The Civil Human Rights Front, or-

ganizer of the mass protests, is gearing up for an annual pro-democracy march on July 1, the 22nd anniversary of Hong Kong's handover to Beijing.

The group has called on people to turn out in force. Beijing has said it supports Lam's decision to suspend the extradition bill, but has been angered by criticism from Western capitals, including Washington, about the legislation.

U.N. High Commissioner for Human Rights Michelle Bachelet urged Hong Kong authorities on Monday to "consult broadly before passing or amending" the extradition bill or any other legislation. The extradition bill triggered the most

violent protests in decades when police fired rubber bullets and tear gas to dis-perse the crowds earlier this month.

### **Automated system for** sales tax registration to take effect from July 1st

The Federal Board of Revenue (FBR) has announced that the automated system for sales tax registration will be effective from July 1st, 2019. In a statement issued on Monday, the revenue authority explained the procedures regarding the use of said the automated system. According to the statement, the applicant having NTN/income tax registration shall, using his login credentials, upload the following information/documents:

• Bank account certificate issued by the bank in the name of

- the business.
- Registration/consumer number with the gas and electricity
- Particulars of all branches in case of multiple branches at
- arious locations. GPS-tagged photographs of the business premises
- . In the case of a manufacturer, also the GPS-tagged photographs of machinery and industrial electricity or gas meter installed.

On furnishing the above documents, the system shall register the applicant for sales tax. After registration, the applicant or his authorised person shall visit e-Sahulat Centre of NADRA within a month for biometric verification. In case of failure to visit or failure of verification, the registered person's name shall be taken off the sales tax active taxpayer list. In the case of a manufacturer, the board may require post verification through field offices or a third party authorized by the board. In case, the field office, during scrutiny after the registration, finds that any document provided is non-genuine/fake/wrong, it may request through the system, to provide the missing document, in 15 days, failing which the registered person shall be taken off from the active taxpayer list.

## **SENATE APPROVES 65** RECOMMENDATIONS ON **FINANCE BILL 2019-20**

HE Senate of Pakistan has unanimously approved 65 recommendations on the Finance Bill 2019-20 as well as 68 recommendations on the Public Sector Development Programme (PSDP) 2019-20, the Senate's Standing Com-mittee on Finance, Revenue and Economic Afreported on Monday.

Committee chairman Senator Farooq H Naik moved the recommendations, which were adopted by the house unanimously.

The Upper House approved the recommen-dation by Senator Shibli Faraz to abolish Ribah

from the country's economy at the earliest.

Meanwhile, proposals by Senator Kalsoom
Parveen to give 10pc of basic salary as ad-hoc relief to all federal government employees of grade 17 and above, and 20pc to the employees of up to grade 16 were also approved.

mendation that ad-hoc relief allowances of 10pc for year 2016, 2017, and 2018 should be merged in the basic pay of civil servants and armed forces.

The Senate recommended that the tax rate on dividend income was 15pc for individuals, which was very high and it should be reduced to 10pc as provided earlier. It also approved the recommendation to give tax exemption to those salaried

people that earn up to Rs90,000 per month.

The Upper House approved the finance committee's recommendations to allocate Rs750 million for Naltar-Gilgit Power Plant, Rs300 million for Naltar Expressway, Rs302 million for Harpo Power Plant, Rs200 million for a 50-beded cardiac hospital in Gilgit, Rs100 million for a polytechnic institute in Skardu, Rs3.85 billion for the sewerage and sanitary system for Gilgit, Rs2.1 billion for widening of 65-kilometre Botogah Road in Chillas, Rs750 million for Karagah energy corridor roads, Rs2.7 billion for a medical college in Gilgit, and Rs500 million for a

The Senate also approved the recommenda-tion of lowering the fiscal deficit target by 1pc from 7.1pc to 6.2pc of the GDP and also of re-ducing the fiscal deficit gradually to 5pc in the year 2020-21, and then 4pc in FY2021-22.

The house approved the recommendations of freezing the exchange rate to Rs150 per USD, besides fixing the policy rate at 9pc and making efforts to increase GDP growth rate up to 4pc.

The committee's recommendation to place

all important debt agreements that make Pakistan liable, such as IMF, should be placed before par-liament immediately, was also approved.

The Senate cleared the recommendation that PSDP allocation for the Ministry of Climate Change should be enhanced minimum by 15pc.
It recommended the National Assembly

that an exemption of sales tax for three years should be granted to the brick kilns who were upgrading their production to ensure environment-friendly standards.

## FPCCI vows to support govt in drive against tax evaders

The Federation of Pakistan Chamber of Commerce and Industry (FPCCI) on Monday vowed to fully support the government in its crack-down on tax evaders, as doing that was imperative to broaden the tax

base and document the economy.

In a statement issued by the chamber, FPCCI President Eng Daroo Khan Achakzai urged the business community to avail the government's tax amnesty scheme by declaring their undis-closed assets by June 30, 2019, so that they could avoid any scrutiny in the future.

He said that the amnesty scheme would help put the economy on sound footings, besides lessening the burden on the existing

Achakzai noted that Pakistan was the 6th largest country in the world but hardly one per cent of the

population was paying taxes.

"One per cent Pakistanis are bearing the burden of 220 million people. This is impossible," he said.
"No country can serve its people if tax evaders are not brought under the tax net.

He said that the amnesty scheme launched in 1958 helped re cover Rs1.12 billion from unde clared assets, followed by Rs920 million in 1968, Rs1.5 billion in 1976, Rs10 billion in 2000, Rs3.16 billion in 2008 and around Rs120 billion in 2018

In comparison, he added, the amnesty scheme launched by In-

donesia in 2016 had brought around 745,000 persons into the tax net and recovered over \$330 billion from undeclared assets

Meanwhile, United Business Group Chairman Iftikhar Malik reiterated that the government should follow the Indonesian model of amnesty scheme so as to extract maximum benefits for the economy, adding that the validity of the scheme up to 30th June 2019 was a

very short period for its success.

He said increasing the tax base
was imperative for provision of
better economic and social serv-

ices to people.

"Taxation and growth should go hand in hand, and it can only be done through a fair and transparent system, he remarked. "If the growth of business and economy will be

choked, there will be no increase in tax collection.\*

He said that the ratio of taxpay-

ers in Pakistan was even less than Afghanistan, adding the broadening of tax net was the need of the hour as it was the only option for the country's sustainability.

Malik said Pakistan needed an amnesty scheme because people had transferred their money abroad due to terrorism and poor law and order situation in the past.

\*The law and order situation is now fully restored in the country and people can bring their money back by taking full advantage of the new scheme," he added. He urged the government to rec-

tify all anomalies in the budget on top priority in order to promote ease of doing business in the country.

## Huawei's US research arm builds separate identity

The US-based research arm of China's Huawei Technologies Co Ltd - Futurewei Technologies Inc - has moved to separate its operations from its corporate parent since the US government in May put Huawei on a trade blacklist, according to two people familiar with the matter.

Futurewei has banned Huawei employees from its offices, moved Futurewei employees to a new IT system and forbidden them from using the Huawei name or logo in communications, a Futurewei employee told Reuters on condition of anonymity. Huawei will continue to own Futurewei, the employee said. Milton Frazier, Futurewei's general counsel,

declined to comment on the separation or the strategy behind it, referring questions to Huawei spokesman Chase Skinner. Skinner did not an-swer questions about the effort.

swer questions about the effort.

The division of operations, which has not been previously reported, comes as many US universities have halted research partnerships with Huawei in reaction to U.S. government allegations that the company poses a national security threat. Many universities are also rethinking their partnerships with other Chinese firms.

Huawei is among the world's largest telecommunications equipment manufacturers. The Commerce Department in May placed the firm on its "entity list" of organizations that pose security risks. The Justice Department earlier filed charges against the firm alleging theft of trade secrets and other crimes

Futurewei is Huawei's US-based research and development arm. The firm employs hun-dreds of people at offices in Silicon Valley and the greater Seattle, Chicago and Dallas areas, ac-cording to its workers' LinkedIn pages. Fu-turewei has filed more than 2,100 patents in such areas as telecommunications, 5G cellular networks, and video and camera technologies, ac-cording to data from the United States Patent and Trademark Office.

Until now, Futurewei's operations have been largely indistinguishable from Huawei, the Futurewei employee said. Futurewei had no sepa-rate brand or even a website, the employee said, and its staff often identified themselves as Huawei employees.

Both companies have conducted a wide range of research partnerships and grant programs with U.S. universities.

Last year, 26 members of Congress sent a letter to Education Secretary Betsy DeVos, warning that Huawei's partnerships with at least 50 US universities "may pose a significant threat to national security."

The fear is that Huawei is using university

partnerships to scoop up research in areas such as artificial intelligence, telecommunications and robotics, which could be used in hacking or spying operations or to give Chinese companies an edge over US competitors.

Some universities are struggling with whether they can continue partnerships with Fu-

turewei - which is not on the government's entity list - even as they suspend funding and research arrangements with Huawei.


The University of California-Berkeley, for instance, is allowing researchers to keep working with Futurewei after suspending all funding and information exchanges with Huawei in May, ac-cording to guidance to faculty from Berkeley re-search chief Randy Katz.

Berkeley also suspended funding from Fu-turewei but continues to allow Futurewei employ-ees to participate in research reviews under certain restrictions, Katz wrote to faculty. Berkeley staff and students now can work only with Futurewe employees who are U.S. citizens or legal permanent residents and who agree in writing not to

share certain sensitive information with Huawei. Companies on the entity list are banned from buying parts and components from American firms without U.S. government approval. Most universities have also consulted the list when making decisions on grants or partnerships, said Tobin Smith, of the Association of American Universities.

Katz said he issued his guidance on Futurewei out of an "abundance of caution" to en-sure researchers don't break laws that prevent sharing sensitive U.S. technology with entitylisted companies. After consulting with the Com-merce Department, Berkeley determined that Futurewei was not covered by the same restrictions as Huawei, Katz wrote to faculty. AGENCIES

### **PSX plunges 653 points** amid low turnover

Stocks bled on the first trading session of the week, as the KSE-100 index benchmark nosedived over 700 points intraday amid low market turnover. Foreign investors closed the previous week (from June 17 to June 20) as net sellers with a net outflow of \$5.89 million. On the economic front, Adviser to Prime Minister on Finance Dr Abdul Hafeez Shaikh tweeted on Monday that Pakistan has secured another bailout package of \$3 billion from Qatar. Following the package, Pakistan's total loans from friendly countries have reached \$16 billion within one year's time. Moreover, as per news reports, the government has surpassed its annual target of foreign loans in 11 months, acquiring \$9.5 billion from international creditors for repayment of previous loans and for failure in achieving the \$27 billion export target. Gross foreign loan disbursements from July to May of the outgoing fiscal year were higher than the annual budgetary target of \$9.3 billion Declining by 756.79 points, the KSE-100 Index benchmark touched its intraday low of 34,368.46. It settled lower by 653.30 points at 34,471.95. The KMI-30 Index sank by 1,561.87 points to close at 55,144.34, while the KSE All Share Index plunged 346.89 points, closing at 25,275.81. Out of the 324 traded scripts, 47 advanced, 257 declined while the value of 20 remained unchanged. The overall trading volumes remained thin and were recorded at 78.12 million (-28pc). K-Electric Limited (KEL 0.00pc), TRG Pakistan Limited (TRG -5.52pc) and Fauji Cement Company Limited (FCCL -6.14nc) remained the volume leaders of the day. The scripts had traded 6.40 million shares, 5.40 million share and 4.18 million shares respectively. The oil and gas and 4.16 million shares respectively. The oil and gas marketing sector chipped off -3.41pe from its total market capitalization. Hascol Petroleum Limited (HASCOL-4.96pc), Sui Southern Gas Company Limited (SSGC -4.42pc, Sui Northern Gas Pipe line Limited (SNGP -3.11pc) and Pakistan State Oil Company Limited (PSO -3.42pc) closed in red. ### **Gold reaches record** high at Rs79,200 per tola

The value of gold in Pakistan has hit a record high, as the per tola price of the yellow metal reached 79,200 on Monday after an increase of Rs600. The price of 10-gram gold also witnessed an increase of Rs 1,069 and was traded at Rs68,029. The price of 10-gram gold was recorded at Rs66,958 on Saturday. In the international market, gold climbed towards the near six-year high reached in the previous session, driven by dovish signals from global central banks and increased tensions between the United States and Iran. Spot gold was up 0.5pc at \$1,405 an ounce by 1240 GMT, headed for a fifth straight session of gains. Gold prices hit \$1,410.78 on Friday, their highest since Sept 4, 2013. US gold futures rose 0.7pc to \$1,410 unce. "The weakness of the US dollar, gold's nical picture and interest from investors themselves have become self-sustaining factors, especially after the massive inflows into gold exchange-traded funds," Commerzbank analyst Eugen Weinberg said.

## STEEL INDUSTRY CRIES FOUL OVER 'UNFRIENDLY BUDGET'

S the local steel industry was struggling to keep up with the regional competitors, the budget presented by the incum-bent government would further hamper the already dwindling industry, it was

learnt on Monday.

Sharing how the budget proposals were "unfriendly" for the steel industry, officials at the Pakistan Association of Large Steel Producers (PALSP) claimed that some of the measures in-troduced in the next budget would add to the

woes of the steel industry.
"Instead of facilitating/compensating the industry through remedial measures, the government has introduced certain measures that would not only cause revenue losses but would also re-sult in the closure of steel units in the settled

areas of the country," they added.

According to the PALSP officials, during the last six months or so, the local steel industry has witnessed a severe crisis with many units being

closed down.

"Some of the leading players, who, a year ago, were showing record performance and profits, are cutting their productions, and are going in big losses," they informed. "A year ago, all those players who were planning to make huge. investments for further expansions have put their projects on the hold."

They said unless the government takes concrete measures to rescue the local industry, this situation would result in rapid de-industrializa-tion and closure of the local industry.

The officials said that the steel industry, through budgetary proposals, had requested the government to remove customs as well as reguduty on the raw material.


"However, the paltry relief provided by the government with the removal of 3pc customs duty is too small and it is not going to provide any meaningful relief to the local steel industry."

As per the official's, the most pressing issue for the industry was the government's decision to allow duty-free raw material/scrap for the in-dustrial units located in FATA and PATA. "This the settled areas, besides severely damaging the national exchequer," they added. The PALSP members recalled that in the re-

cent past, a large amount of re-rollable scrap its way into the Pakistan market due to faulty duty structure of the government

\*In order to discourage such activities, the local industry had appealed to the government to increase customs/additional customs duty and regulatory duty on the re-rollable scrap. However, contrary to the recommendations of the local industry, the government has further reduced the duties on this intermediary good which is a substitute of the billets."

They further recalled that in the recent meeting of Senate's Standing Committee on Fi-nance, members of the steel industry from all segments – ship breakers, melters as well as re-rollers, had pleaded the government to impose more duties on the re-rollable scrap in order to save the local industry from closure. However, they added, the government failed to take the much-needed measures.



## Textile exports increase 2pc to \$11.4bn

The exports of textile and its articles from the country witnessed an increase of 2.17 per cent during the first ten months of the current fiscal year as compared to the exports of the correspon-ding period last year, State Bank of Pakistan (SBP) reported on Monday.

The textile exports from the country during July-April 2018-19 were recorded at \$11,419 billion against the export of \$11.176 billion during July-April 2017-18. The textile commodities that contributed positively in the external trade in-cluded apparel articles and clothing accessories (knitted), the export of which grew from \$2.24 billion last year to \$2.50 billion during the current fiscal year, an increase of 11.87pc

The exports of apparel articles or clothing accessories (not knitted) increased by 2.22pc, from \$2.06 billion to \$2.11 billion, whereas the ex-

ports of other made-up textile articles increased by 0.39pc, from \$3.38 billion to \$3.39 billion. Similarly, the export of knitted or crocheted fabrics grew by 25.56pc, from \$23.33 million to \$29.29 million, while the exports of man-made filaments increased by 29.58pc, from \$17.94 mil-lion last year to \$23.25 million.

Meanwhile, the textile commodities that wit-Meanwhile, the textile commodities that win-ressed negativity in external trade included cot-ton, exports of which dipped by 1.57pc, from \$2.97 billion last year to \$2.92 billion. The export of carpets and other textile floor coverings decreased from \$69.815 million to

\$65.929 million, a decline of 5.56pc, whereas the export of man-made staple fibres decreased by

3.14pc, from \$252.82 million to \$244.86 million.

It is pertinent to mention that the country's rehandise trade deficit plunged by 13.62 per cent during the first eleven months of the current fiscal year compared to the corresponding period of last year, according to the Pakistan Bureau of Statistics (PBS).

The trade deficit contracted by 13.62pc to \$29.20 billion during July-May 2018-19, as against the deficit of \$33.81 billion recorded during July-May 2017-18.

Exports during the period under review witnessed a nominal decrease of 0.3pc, as it fell from \$21.35 billion last year to \$21.26 billion during the ongoing fiscal year.

On the other hand, the imports declined by

8.47pc to \$50.474 billion during the period under review from \$55,142 billion last year.

ORMER world number one Andy Murray says he could resurrect his singles career at this year's US Open following a remarkable re-turn to tennis with victory in the men's doubles at the Queen's Club tour-

## All hail the 'new queen': Australia piles praise on top-ranked Barty

Australia hailed "humble and inspira-tional" Ashleigh Barty as the new queen of tennis Monday after she joined Evonne Goolagong Cawley as the country's sec-ond woman to reach world number one.

The French Open champion claimed the top spot by beating Julia Goerges to win the Birmingham WTA title on Sunday, capping a remarkable rise by the 23old who once quit tennis to play

Along with Goolagong Cawley, who briefly held the top rank in 1976, she em-ulated John Newcombe, Pat Rafter and Llevton Hewitt in the pantheon of Ausns to reach world number one. Tennis Australia chief Craig Tiley

commended a "remarkable historical ac-complishment". "It's a really hard thing to do and to achieve, that is just fantastic," he told the Channel Nine TV network. "I know her, she's humble about it. She just wants to get back on the tennis court and have a good hit."

Goolagong Cawley, who like Barty has an indigenous heritage, said her rise had been "almost unstoppable".

"Ash is a very worthy number one

and winning at the French will have given her even more confidence," she told reporters.

"I am so proud that another Aboriginal player sits on top of the rankings in women's tennis, particularly a young lady who conveys such happiness in all

A win for Australia at Lord's would heap added pressure on England, who are yet to face the two undefeated sides of the tour-nament, India and New Zealand, and Langer expects the match to be decided by which team can best deal with their nerves. "You can look at it two ways. Langer said. "We all have a bit to do.
They have three games. They will be tough games but it will be like that in the semi-final. They should be welcoming that. If you are nice and battle hardened, then you might be weary, but you will be ready for the contest. For both teams, it is a good thing. We have England, New Zealand and South Africa, teams we have had good contests with. It is a positive for whoever makes the semis, if they are playing tough cricket going into it. \*This tournament is going to be about who can hold their nerve in the big moments. We have got to concentrate on how we hold our nerve in the big moments. There are going to be plenty of them in the next three games and hopefully the semi-final. "I have said for 6-8 months, when it comes to a World Cup there is a lot of talk about statistics, but it comes down to match play and we have to play England on Tuesday better than they play us."

## Pakistan 'alive and kicking' as team eyes unlikely World Cup survival

LONDON

Pakistan find themselves "alive and kicking" in the World Cup despite a disastrous start as coach Mickey Arthur warned his unpredictable team were still gunning for the semi-finals

The 1992 champions were on the brink of elimi-nation after losing three of their first five games, in-

cluding a bruising defeat to arch-rivals India.

But Sunday's 49-run win over South Africa has kept alive Pakistan's chances of qualifying for the last four. They now need to win their remaining three matches against New Zealand, Afghanistan and Bangladesh, and hope other results go their way.

New Zealand are top of the 10-team table ahead of Australia, India and England, followed by Sri Lanka, Bangladesh with Pakistan in seventh place.

However, England, smarting from their upset against Sri Lanka, will be out of the running for the last four if they lose their remaining three games against Australia. India and New Zealand.

Even table-toppers New Zealand can lose their last three and not qualify – a scenario that is giving Pak-istan hope. "We are alive and kicking, without a doubt," said Arthur. "Yes, we are banking on other

teams doing us a favour. It probably is - but we've got to win three games." Arthur said Pakistan, who stu England earlier in the tournament, can beat any team

if they play to their potential.

"When we play our best game, we can beat any-body. Whether that's New Zealand, Afghanistan, Bangladesh, our remaining games, or England, we showed. "We put our three disciplines together, we are as good as any team in this competition. We are very firmly in the World Cup. We win our next three games, we'll qualify. "Arthur said his players came out fighting after their defeat to India in Manchester

\*Our boys hurt, all of us hurt, incredibly. Guys didn't sleep much, but they came to the training every day and put in (hard work) in order to try and turn it around, and we got some just reward against South Africa." Pakistan still need to hugely improve their sloppy fielding, dropping as many as five catches against South Africa - three of them by Mo-

"Our problem is we haven't put three disciplines together yet in any game," said Arthur whose team scored 308-7 against South Africa before restricting them to 259-9. "We bowled well; we batted well; we didn't field well (against South Africa). So when we

"The closest we've got was when we heat Eng-land." Underlining Pakistan's mercurial nature, the 14 run win over top-ranked England followed their seven-wicket defeat against the West Indies, when they were shot out for 105 in their opening game.

Meanwhile, Pakistan's head coach Mickey Meanwhile, Pakistan's head coach Mickey Arthur believes that Pakistan's performance against South Africa on Sunday at Lord's will silence the critics for a bit. "I just think the guys were burnt out last week. The guys were incredibly hurt by media, public, social media... And hopefully, we got a proper reaction from them today that can just shut some peo-ple up for a little while," he said.
"Our guys need to be built up all the time. The

minute they are bashed, like they have been the last week, our guys don't respond to that in a very kind way and hopefully, we got a performance out today that vindicates the talent the boys have on the team,"

## England's World Cup nerve faces Australia test

Are England just a bunch of "flat-track bul-Are England just a function of near-track out-lies?" That's the uncomfortable question facing Eoin Morgan's side as they look to get their World Cup campaign back on track against arch-rivals Australia. Tuesday's match at Lord's was always

going to be a showpiece occasion, but it has been given added spice by England's 20-run loss to Sri Lanka.

Faced with a relatively modest target of 233 on a tricky Headingley pitch, Eng-land slumped to 212 all out.

Despite their second defeat of the pool

phase following an earlier loss to Pakistan, the tournament hosts remained in the top four and on course for a semi-final spot.

But England, bidding to win the World Cup for the first time, cannot afford many more slip-ups in their remaining pool fixtures against fellow title contenders Aus-tralia, India and New Zealand -- teams they have not defeated at a World Cup since 1992. England's rise to the top of the oneful first-round exit at the 2015 World Cup

They have twice posted a world record score at this level in the intervening four years, including the current mark of 481-6 against Australia at Trent Bridge just over against Austru. 12 months ago.

DUMB CRICKET: Doubts, however, persist about England's ability to bat in less than ideal conditions for shot-making.

Their problems were summed up against Sri Lanka when Moeen Ali marked his 100th ODI by hitting a six, only to try to repeat the shot next ball and hole out to England 170-6, Former England captain Michael Vaughan was unimpress writing in Britain's Daily Telegraph: "He (Moeen) was there to win the game but it was dumb cricket taking on the man at long off having just hit the ball for six."

According to research by cricket stat-isticians CricViz, on the 11 toughest oneday pitches for batting England have played on since losing to Pakistan in the 2017 semi-finals of the Champions Trophy on a slow Cardiff surface, they have lost five. By contrast, on the 11 best pitches for

Morgan's men have won nine. England's problems have been com-

pounded by the absence of Jason Roy from their past two matches, with a torn ham-string threatening to sideline the in-form opener from the Australia clash as well.

Yet while former players such as Vaughan bemoaned England's lack of nous against Sri Lanka, Jos Buttler said the prob-

lem was they were not aggressive enough.
"I think we were a little bit passive as a group," said the usually big-hitting Buttler, who made just 10 before becoming the last of four wickets for veteran paceman Lasith Malinga. "That doesn't just mean hitting fours and sixes, that means showing intensity and trying to put pressure back on the bowlers," he said.

"However, I promise it would definitely be spent on them." The PM gave two assur-ances during his comments: That "nobody will be allowed to harass the tax-payers" and that the Federal Board of Revenue and that the Federal Bo (FBR) "will be reformed"

Further, he clarified that non-custom-

### **Donald Trump imposes new** economic sanctions on Iran

United States President Trump announced on Monday that he is imposing new sanc-tions on Iran, after saying for days that he preferred tightening the pressure on a crippled Iranian economy to launching an im-mediate military strike in retaliation for what American officials have said are re-

cent aggressive acts by Tehran.
"We will continue to increase pressure
on Tehran," Mr. Trump said as he sat at his desk in the Oval Office preparing to sign an executive order. "Never can Iran have a nuclear weapon." He added that the order will bar Iranian leaders from access to financial instruments. The administration did not im-

instruments. The administration did not im-mediately elaborate.

The Trump administration already moved this spring to cut off all revenues from Iranian oil exports, the lifeblood of the nation's economy, and the new sanctions are expected to be aimed at shutting down additional sources of income with the goal of forcing political change in Tehran,

Mr. Trump and his top foreign policy aides are gambling that continuing the squeeze on Iran will compel its leaders to buckle to demands to limit their nuclear program in ways that go beyond the landmark agreement that major world powers forged with Iran in 2015 — and that Mr. Trump withdrew from last year.

Secretary of State Mike Pompeo, who met with the rulers of Saudi Arabia on a last-minute trip on Monday, also insists Iran must curb its regional military activity and end support for partner Arab militias. The imposition of more sanctions could provoke further actions by Iran to add to the crisis that has unfolded since early May in the Persian Gulf and Gulf of Oman, an-
